**CHANGES TO THE COMPOSITION OF THE BOARD OF DIRECTORS AND BOARD COMMITTEES OF THE COMPANY**

- (a) Mr Tan Sek Khee has resigned as an Independent Director of the Company. Following his resignation, he shall step down as the chairman of the Remuneration Committee (“**RC**”) and a member of the Audit Committee (“**AC**”) accordingly.
- (b) Mr Loh Weng Seng Vincent (“**Mr Vincent Loh**”) has been appointed as an Independent Director and the chairman of the RC of the Company.
- (c) Madam Ma Jieyu has been appointed as a member of the AC of the Company.
